Meeting adjourned at 4:02 P.M.

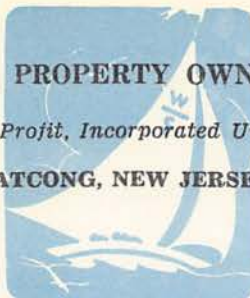
