

ANNUAL MEETING

September 1st, 1962

Attendance: 33 Members including 8 Board of Governors.

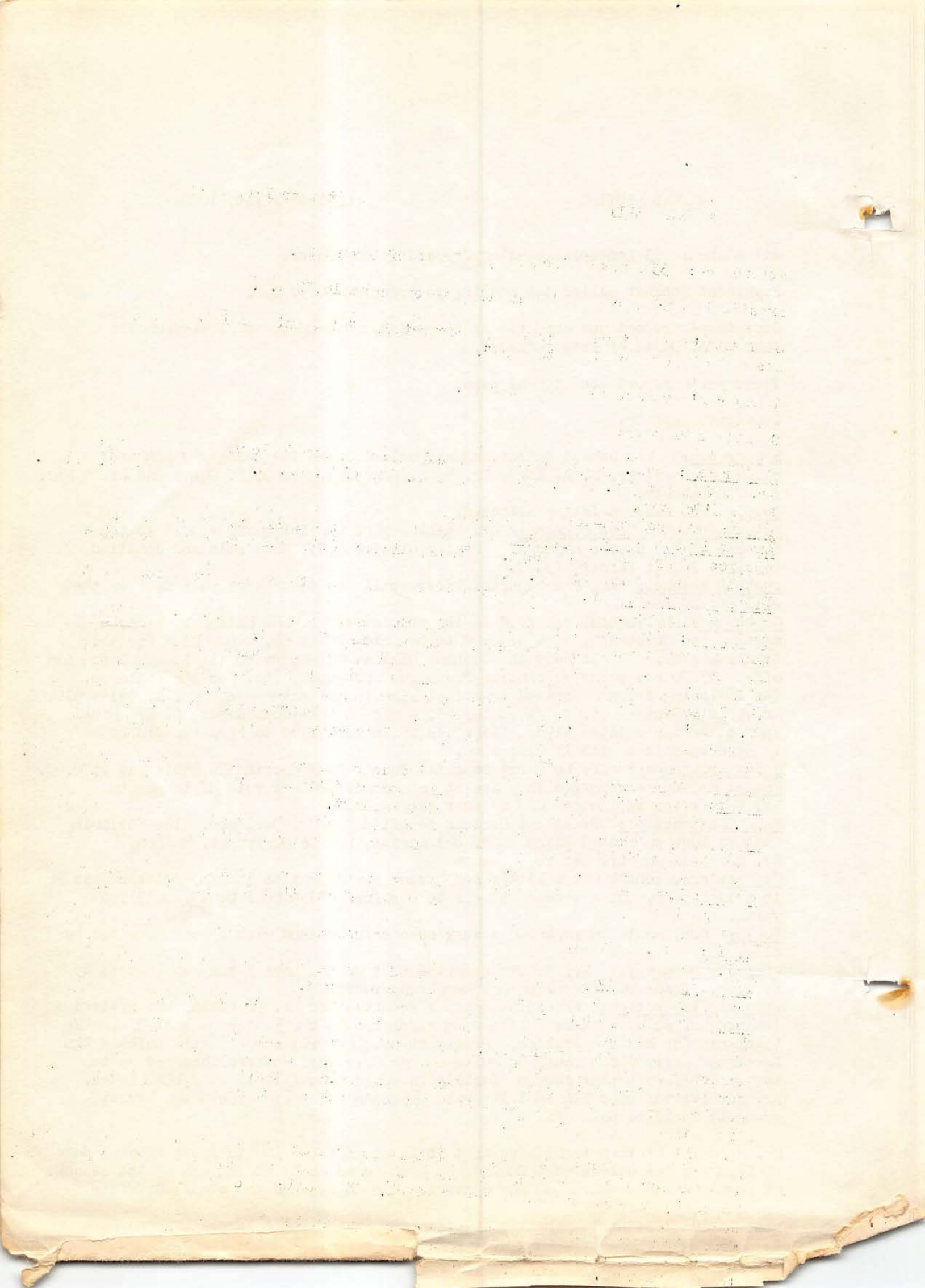
YOUTH: Mrs. Montalto reported a very successful season with a good time had by all.
