COMMITTEE REPORTS

Docks & Beaches

Mr. Malanga inspected the docks and beaches and found the following necessary repairs:

Pebble Beach: The bottom steps and three pilings at the base required repair. This has been done at a cost of \$90.00.

Sand Harbor Beach: One boat guy cable and one piling required repairs. One pipe piling was replaced with pole piling and the boat guy and cable repaired at a cost of \$80.00.

Mr. Malanga suggested that a four foot cyclone fence be installed to show the property line.

Pool: Cap top of platform has to be repaired.

Mr. Gulamerian requested that an aluminum ladder be installed at the Pool, as the one presently there is in "very sad shape".

BassRock: The retaining wall should be repaired. An estimate for this work will be obtained.

Mr. Malanga presented a drawing of proposed extension to dock at Sand Harbor Beach. The plans for this job will cost approximately \$900.00.

The proposal was discussed considerably and Mr. Franchino, Mr. Krauth and Mr. Malanga will get together during the week and go over the situation more thoroughly and submit their findings at the next meeting.

Mr. Honchar remarked that it is necessary to obtain a Permit to build a dock.
