Docks & Beaches

Mr. G. Malanga presented estimates in the amount of \$243.10 (galvanized fence covered with vinly plastic) and \$235.20 (galvanized) for 84 feet of 42" high fencing to be installed at Sand Harbor Beach. (Gate to be donated by Mr. Malanga)

Mr. O. Malanga moved, seconded by Mr. Sayre, that the cyclone fence be installed at Sand Harbor Beach at a cost of \$243.10 and Mr. Malanga was instructed to make necessary arrangements with E. J. Corvett Co., Inc.

Mr. Hart questioned the replacement of ladders at the beaches and pool.

Ladders at pool are to be replaced and one installed at Pebble Beach.

Mr. Hart said he would look into the cost of ladders as he felt, as did other members in attendance, Mr. Stichling's price of \$100.00 per ladder was quite high.

Mr. Hart said he would make up parking area signs.

Mr. Krauth moved, seconded by Mr. M. Malanga that the Boardson the dock at Pebble Beach be removed and replaced.

Legal Committee

Mr. Corbin had no report at this time. However, he did feel, the excise tax question might in some way be tied in with the water situation.

The Form from the Tax Assessor's office will be completed by the Association and returned.

Mr. Davidson advised the Board he had received a Release from Mr. Dutcher for execution, by him as Association President. Mr. Corbin stated it was proper to execute same.

Old Business

Mr. Krauth reported Purdy Agency is binding liability coverage until such time as inspection is made and determination as to whether or not a policy will be issued.

New Business

Mr. Davidson read Mr. Heidorn's letter of resignation as legal advisor to the Board.

It was the concensus of opinion of all those present that this should be "tabled" for consideration at a later date. (Much later)
