

November 14th, 1965

Mr. Krauth reported that survey work has not been started as yet, but will be shortly.

Mr. Krauth also recommended a letter be sent to Mr. & Mrs. Mariano regarding dock location and requesting disposition of same.

##### Legal Department

Mr. Corbin reported there are no charges in the Water System acquisition. On or about 12/1/65, there should be some definite conclusions.

##### Docks and Beaches

Mr. Davidson reported he had checked into necessary repairs to docks and beaches. Mr. Davidson, together with committee made up of Mr. Gulamerian and Mr. Myers, will meet with contractor to discuss recommendations, repairs, and cost of same, which will be presented at next Board Meeting for discussion and approval.

Mr. Bacquet asked about letter to membership highlighting actions of Board of Governors.

Mr. Franchino said in view of the length of this meeting, discussion will take place at next meeting. He recommended all Chairmen have their reports ready for the President for incorporation into final letter.
