

March 21st, 1965

Meeting of Board of Governors of Wildwood Shores Property Owners' Association was called to order at 2:40 P.M., by the President on March 21st, 1965.

Members present were: Mr. Davidson, Mr. Gulamerian, Mr. Keiser, Mr. Winkler, Mr. Corbin, Mr. Krauth, Mr. Honchar and Mr. G. Malanga.

#### Secretary's Report

Mr. Keiser moved, seconded by Mr. Krauth that the minutes of meeting of February 28th, 1965 be accepted as read. Motion carried.

#### Treasurer's Report

Mr. Krauth moved, seconded by Mr. Honchar, that the Treasurer's Report be accepted and made a part of the minutes. Motion carried.

#### Committee Reports

##### Docks & Beaches

Mr. Malanga reported that because of the bad weather, necessary dock work cannot be started, but early in April he and the committee will work out installation of boat slips and catwalks at the designated beaches. Mr. Malanga suggested that immediate steps be taken to develop the parking area at Pebble Beach and work to install slips and catwalks be started at this beach first.

Mr. Malanga presented drawings prepared by Mr. Von Borstel, for installation of slips and catwalks at Sand Harbor, Pebble Beach and Bass Rock, with the cost of each project showing on drawings.

In view of the foregoing necessary work, Mr. Malanga moved, seconded by Mr. Krauth that the docking space fees be increased \$10.00 per boat to \$30.00 for the current year, to help defray cost of improving docking facilities. Motion carried.

All members who have had boatspace in the past are to be notified and charged the new rate for this year when the bills for membership dues are mailed out.

Mr. G. Malanga moved, seconded by Mr. Winkler, that Mr. Von Borstel be authorized to proceed with work at Pebble Beach in accordance with drawings and specs as proposed by him. Motion carried.

Mr. Malanga asked about installation of lights at the docks. The big question seems to be should one be installed at Bass Rock. The feelings of all members present were given for and against this; resulting in the following motion:

Mr. Krauth moved, seconded by Mr. Gulamerian, that after polling immediate residents of the area, and if the majority is in agreement, that a light be installed at Bass Rock. Motion Carried.

##### Roads

Mr. Keiser reported that he has worked out an agreement with Mr. Albinson that Clearwater Trail will be plowed in the future.

The lane leading to the Pool will be checked & repaired as soon as weather permits.
