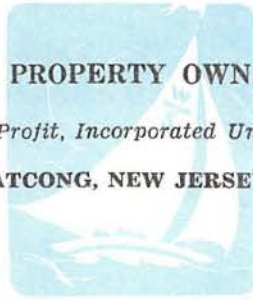

Dear Member:

"Coming of Age" - remember this quotation? Well in case you have forgotten, "Coming of Age" was the beginning of a most important letter to the members of W.S.P.O.A.

As we all know growing up is not easy and certain growing-pains accompany "Coming of Age". The Board of Governors has worked hard to make each step easy for you. A committee on "By-Laws" headed by Mr. Henry Heidorn held many long sessions to come up with a new set of "By-Laws" which are in keeping with our new status.

After the "By-Laws" committee completed its task the Board of Governors spent several sessions going over the proposed "By-Laws" paragraph by paragraph, word for word. As a result, we offer a new set of "By-Laws" to the general membership and they will be voted on at the spring meeting scheduled for 10:00 AM on Saturday, 24 June 1967.

The Board urges you to accept the new proposed "By-Laws" in all areas except the two where we could not agree. The proposed "By-Laws" include Article VII, Section (1) and Section (2) as written by the committee and accepted by a majority vote of the Board. At the general meeting, a minority report will be given as to why Article VII Section (1) and Section (2) should be revised or rewritten.

Another important topic was discussed in the President's letter of 23 February 1966. You will recall that your association was offered the remaining "land company" properties in the Wildwood Shores Tract. The Board has been authorized to make the purchase and the closing date is very soon. Many who pledged support by the purchase of promissory notes have done so; however, we still need help and urge that you purchase your notes now.

In addition to the copy of the proposed new "By-Laws" we are including with this letter "Information on W.S.P.O.A." badges. Please read this important memo and cooperate with those who donate their time in this effort.

As previously mentioned the spring meeting will be held 24 June 1967 at the Clubhouse at 10:00 AM. Please attend and support the work your Board is trying to do.

Information Regarding Badges

Beginning with May 15, 1967 and for the balance of the Summer and Fall, all members and their guests using any of the docks and beaches of this Association will identify themselves by wearing a W.S.P.O.A. badge. Anyone not wearing a badge will be considered as a trespasser.

The people who do not have badges can obtain them at the residence of any of the following:

The cost of badges for the '67 season is per the following schedule:

(2) Member Badges	- No charge upon receipt of dues
Additional Member Badges	- 50¢ each
Guest Badges	- \$1.00 each
Day Guest Badges	- 50¢ per day plus \$1.00 each returnable deposit
Renters Badges	- \$3.00 each (for period of two weeks or less) plus \$2.00 each returnable deposit
Renters Badges (for season)	- \$6.00 each

The badges are numbered and a record is maintained as to assignment of each badge. Found badges should be returned to any of the three members listed above, who will return them to the rightful owners. Damaged badges may be exchanged for new ones.
