The content of the letter had to do with the method of selecting trustees for the water company as well as length of term and compensation. Many questions were asked of Mr. Corbin as to why certain courses of action were taken when the water system was taken by the association. Mr. Corbin indicated that every move was made with the welfare of the association in mind but since these moves were not interpreted this way he would resign from any further work involving the water system. Mes asked for patience in the matter and a review of the events to be presented at some future date so that a satisfactory arrangement to all might be reached.

Mes Gulamerian told the members present that a review of our insurance policy was made and as a result we were able to obtain a better policy at a lower premium.

The president stated that he had the resignation of Gene Bacquet as secretary-treasurer effective August 13 but the latter had agreed to continue until the general meeting.
