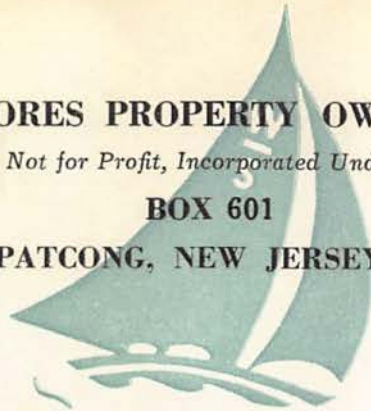

Board of Governor's Meeting

The meeting was called to order at 8.P.M. , September 13, 1968 at the Clubhouse. Present were; Absent were:

After the minutes of the previous meeting were read, Mr. Williams, motioned that they be passed as corrected, seconded by Berdan.

Corrected parg. Myers suggests we stabilize on present boat facilities-first come- first served. Motion passed.

A bill from Mr. Wm Mcnear was presented and ordered paid. The amount was \$54.00 for 3loads of sand for Sand Harbor.

The secretary was asked to inquire into the cost of a safe deposit box at a local bank.(for safe keeping of Deeds, etc. Mr. Rosica and Botti suggested that the WSPOA safe in the club house be used to safe guard papers.

President Claudin announced the following Organizational appointments for the period Sept.1,1968 to August 31, 1969 (see attached Sheet). Discussion of committees as follows

1. Membership. This committee in addition to its normal duties will act as official greeters of the Association.
2. Clubhouse. Mrs Pettigrew will be assisted by the chairman of Boat Mooring and storage.
3. Entertainment: The two appointed will be assisted by others named for Special Events.

Mr Rosica nominated ,seconded by G. Williams , Bill Sutphen to fill the term of Ed Kelly who had resigned. Mr Myers said that Ridge Road section seemed to already be well represented. Mr Botti suggested that Ridge Road seems to have most of those interested in serving or at least coming forth. Motion passed, with one abstention.(Mr Myers)

The new Board in agreement with other boards said that no boats will be stored by member until the fee of \$20.00 is paid and the hold-harmless agreement is signed.

The secretary-Treasurer request that he be bonded in accordance with the association by-laws. Board approved.

Mr. Rosica, seconded by Coughlin motioned that the Association have a petty cash fund of \$50.00. The secretary- treas. will be responsible. Motion passed.


Mr Botti will have the Association's addressing machine repaired and brought up to date. The Board agreed.

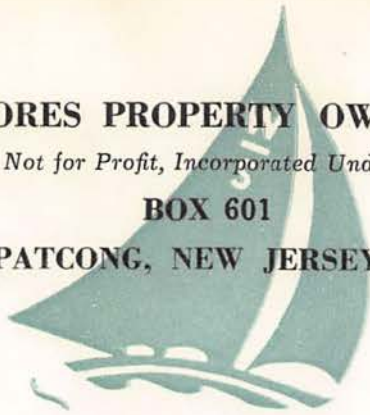
