February 3, 1950

A meeting of the Board of Governors of the Wildwood Shores Property Owners' Association was held at the home of Mr. Wilkinson on February 3, 1950.

All members of the board were notified, and an invitation was extended to Mr. Cutler. Members present: Messrs. Wilkinson, Gates, Swenson, Heidorn, Thober, Scherb and Mrs. Lowery.

The majority of the postcard ballots sent to the members in the fall were returned in the affirmative - with not one dissenting vote. Officers duly elected by majority vote.

Mr. Swenson, treasurer was instructed to write a letter to Mr. Cutler acknowledging rent due on the clubhouse and if, and when he is financially able to make a token payment; also to state that the association would like to rent the clubhouse for the 1950 season on the same basis.

It was brought out at this time that Mr. Cutler thought our dues were not sufficient, and the association should help and participate in the cleaning and upkeep of the clubhouse. Discussion followed.

A motion was made by Mr. Heidorn and seconded by Mr. Scherb, that Mr. Swenson act as chairman of the Finance committee in the absence of Mr. Crise. Motion carried.

Mr. Swenson reported \$360.00 unpaid dues in 1949. A letter requesting payment of dues for 1950 will be sent to all members with delinquent dues statement attached where necessary.

A notice to be forwarded to all association members regarding status of board of governors; meeting May 6th 1950 at clubhouse; and garbage and speeding was discussed; this to be mailed in the immediate future.

Mr. Scherb submitted sketch on locker facilities for Pebble Beach and it was decided that the Docks & Beach Committee get together with the House & Grounds Committee to discuss this project. Mr. Scherb also proposed that docking places be specifically marked at the clubhouse deck. It was proposed that the gates in the pool at the clubhouse be cut and so constructed that they could be raised instead of removing them at the end of each season.

Mr. Gates reported that the water committee still did not have anything definite to report at this time.

No report was submitted from the road committee due to Mr. Rizzo's absence, but the trail adjacent to the Humer-Dinzel property was referred to and the secretary was instructed to attach a memo to Mr. Rizzo's copy of the minutes, asking if any progress had been made on this subject.

There being no further business, the meeting adjourned.
