

BOARD OF GOVERNORS MEETING

July 21, 1961

Absent were the Messrs. Bentzen, Brundage, Malanga Geo. & McGarry.

Pres Krauth called meeting to order at 8:30 P.M.

Secretary's report was accepted as amended. Instead of \$100.00 advanced to the ways and means committee it was \$75.00.

Secretary read a copy of a letter Mr. Clements sent to the Investigation Section of the U.S. Post Office in Wash. D.C. and to the N.J. Police dept. A suggestion was made to read it at the next Annual meeting on Sept. 2nd. Will table this for further action.
