Board of Governors Meeting

Treasurer's Report

Secretary's Report

Mr. Franchino moved, seconded by Mr. Malanga, that the Secretary's report be accepted as read and placed on file. (Carried)

Legal Dept.

Mr. Heidorn reported that the Release for the Crise property had been received.

He also stated that unless there are other liens to be recorded against properties, it would not pay to do it this year. Every two years is best.

It was reported that a reply to the letter sent by the Board to Mr. Skinner, owner of the property now rented to De Walt, had been received. Mr. Honchar talked to Mr. Davis, Agent, for the property. Mr. Davis advised that every effort will be made to correct the unsightly condition.

Meeting interrupted at this point to discuss dues situation with Mr. Pelletier. Mr. Pelletier attended the meeting for a few minutes to clarify his position relative to the dues situation on his properties. Inasmuch as he is selling the small house to Mr. Wood, he paid the dues up to date. MEETING RESUMED-----

He also recommended that the Bonnello property be transferred to Mr. & Mrs. Robert Corbin. Applications of each to be processed further.

#### Building Committee

Mr. Davidson had nothing to report at this time.

#### Docks & Beaches

Mr. Fox reported that the repairs to the pool, because of the severe cold winter weather will cost \$630.00. Mr. Rohn, who submitted estimate for repairs was authorized to proceed with work.

Mr. Fox will investigate mooring situation at Pebble Beach, with the hope that the situation can be corrected.

#### Property Inspection

Mr. Franchino reported that the garbage situation on Ridge Road had been corrected, and that the De Walt problem was taken care of.

#### Property Surveys

Mr. Honchar discussed the surveying of the property at the pool, and it was also recommended that the property between Kuehn and Stichling properties be surveyed.

Mr. Krauth will be advised of the decision and will take care of the matter.

#### ENTERTAINMENT

Nothing to report at this time.

#### Clubhouse

No activity at present, however, all boats now stored in clubhouse to be removed by 5/31/63.

Mr. Davidson asked if outsiders could store their boats in the clubhouse. This will be checked with Mr. Heidorn, as to the Association's responsibility. The amount of storage charge, if we are permitted to do so, will be discussed at future meeting.

#### Roads

No report at this time.

#### New Business

Mr. Mc Garry resigned as Vice President of the Association and also as a member of the Board of Governor's and Chairman of the Space Committee. Mr. Franchino is now the Space Chairman. He will check with Terwillger relative to floating dock to make more boat space.

As there was no further business to come before the meeting, Mr. Malanga moved, seconded by Mr. Schaub, that the meeting be adjourned. Meeting adjourned at 5:00 P.M.

NEXT MEETING TO BE HELD ON MAY 26th, 1963 at 2:30 P.M. at Honchar residence Wildwood Shores.

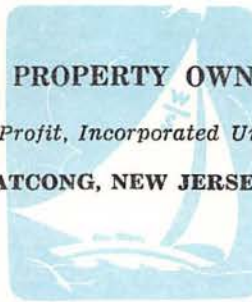


